NORTHWEST SURROGACY CENTER BASE COST ESTIMATES*

Northwest Surrogacy Center Agency Fee: \$15,000.00

NWSC's fee includes having NWSC locate a surrogate, facilitate meetings between you and suitable candidates, provide a draft surrogacy contract and manage the trust account.

\$7,000 is due upon execution of our fee agreement
\$6,000 is due upon execution of your surrogacy contract
\$2,000 is due upon confirmation of a pregnancy
Possible Rematch Fee -- \$2,000

There are many factors that ultimately determine the overall cost of a surrogacy. The estimates given by Northwest Surrogacy Center are estimates only and vary depending on the facts of each case -- your situation may cost more or less than the estimates given.

Initial Deposit for Screening and Surrogate Expenses

After you have been matched with a surrogate, you will be asked to deposit \$4,000 in a trust account to cover your surrogate's expenses that are incurred before the surrogacy contract is signed. Any unused portion of this deposit will be applied to the trust account estimate that we customize based on the terms of your contract after it has been signed. These expenses are outlined below. This \$4,000 is not an additional charge or fee; it is a deposit on expenses.

Surrogate Compensation:

Once you have signed a contract with a surrogate, you will deposit funds in a trust account for your surrogate's compensation. These funds will cover:

Surrogate's fee	\$23,000 for a first time surrogate \$28,000 for an experienced surrogate
Maternity clothing	\$500 (\$750 for multiples)
Monthly expense allowance	\$200 per month for approximately 12 months
Mock Cycle	\$300
Embryo transfer fee	\$800

Screening and Medical Costs:

Psychological Evaluation	\$500
Criminal History Check	\$100
Uncovered Medical Expenses (for items such as co-pay, prescriptions, acupuncture)	\$1,500
Surrogate Medical Screening	Services and estimate provided by IVF Clinic
Uncovered Medical Expenses for prenatal care and delivery	Varies depending on medical circumstances and insurance policy
IVF Cycle and Medication	Services and estimate provided by IVF Clinic

Life insurance

Life insurance	\$250
(Amount is approximate; surrogate receives a one-year term policy which provides benefits in the amount of \$350,000.)	

Legal Fees:

Intended Parent Legal Representation \$3,500-\$5,500**
 NWSC includes the draft of the surrogacy contract in its agency fee, but each party retains independent legal counsel to review and discuss the contract. This estimate also includes fees for legal proceedings in connection with the establishment of Intended Parents' parental rights

Surrogate Legal Representation \$1,600-2,500**
 Intended Parents will pay attorney fees for Surrogate and her spouse or partner for review of the surrogacy contract and for Surrogate's representation for finalization.

**Legal Fees Vary – Portland Attorney rates typically run between \$225-\$300/hr and are paid directly to the attorney

**IN ADDITION TO BASE COSTS THERE ARE THE FOLLOWING
VARIABLE COSTS**

There are a number of costs that may be incurred during the surrogacy process that vary on a case by case basis. These additional costs are approximate and may include:

Medical insurance for surrogate	\$4,500
(Amount is approximate; many surrogates have medical coverage. Intended Parents provide medical insurance for prenatal care, delivery and post-partum care if Surrogate does not have insurance or her insurance is inadequate.)	
Back Up Medical Insurance Plan	\$1,500
(Plus payment of refundable premium if policy is not activated)	
Cesarean Section	\$1,500
Invasive procedures	\$750 per procedure
Additional fee for multiples	\$3,000 per additional child
Loss of uterus (if applicable)	\$2,500
Counseling (paid only if surrogate obtains)	\$1,000
Lost Wages	\$0-\$13,500 (Average \$2,264)
Housekeeping	\$65/week
Childcare	\$10-\$15/hr
Travel (If surrogate is required to travel more than 50 miles one way for screening and/or medical appointments, intended parents will reimburse surrogate for mileage, hotel, meals, childcare, lost wages	\$500-\$1,500

Egg Donor Compensation	\$6,000 (or more if proven donor)
Egg Donor Agency or Administration Fee	Varies
Egg Donor Medical Costs	Estimate provided by IVF Clinic
